PRIVACY POLICY

This Privacy Policy describes how COINBIX collects, uses, and discloses your personal information when you use the COINBIX TRADING PLATFORM, its application, and its trading bots.

By using the Service, you agree to the collection and use of information in accordance with this policy. If you do not agree with the terms of this Privacy Policy, please do not access or use the Service.

INFORMATION WE COLLECT

We collect various types of information to provide and improve our Service for you.

1. Personal Information:

When using our Service, we may ask you to provide certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- A. Email address
- B. First and last name
- C. Phone number
- D. Address, state, province, ZIP code, city
- E. Government identification information (e.g., ID card, passport, proof of residence) for KYC (Know Your Customer) and AML (Anti-Money Laundering) purposes
- F. Cryptocurrency transaction data (wallet addresses, APIs, and transaction history)

2. Usage Data:

This Usage Data may include information such as your computer's Internet Protocol address (e.g., IP address), browser type, browser version, pages visited on our Service, time and date of your visit, duration spent on those pages, unique device identifiers, and other diagnostic data.

3. Tracking and Cookies Data:

We use cookies and similar tracking technologies to track activity on our Service and maintain certain information.

Cookies are small files containing a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies like beacons, tags, and scripts are also used to collect and track information and to improve and analyze our Service.
